NOTICE OF TECHNICAL CONFERENCE AGENDA

(July 21, 2004)

On May 12, 2004, the Commission issued a Notice of Extension to File Comments and Technical Conference, announcing the Commission will convene a technical conference, to be held on July 29 and 30, 2004, in New Orleans, Louisiana. The Commission indicated that the purpose of the conference is to discuss issues raised by Entergy Services Inc.'s (Entergy) proposal in Docket No. ER04-699-000 to, among other things, establish an Independent Coordinator of Transmission (ICT), as well as to address additional proceedings currently pending before the Commission that raise issues of transmission access on the Entergy system. On June 21, 2004, the Commission issued a Supplemental Notice of Technical Conference providing additional information on the location and timing of the discussions.

The Supplemental Notice indicated that the Commission would publish an additional supplemental notice with a detailed agenda and that other issues may be added to the discussion after review of the comments received in Docket No. ER04-699-000. Because certain parties discussed Entergy's recent proposal to amend its Generator Imbalance Agreement in Docket No. ER04-901-000 in their comments filed in the ICT proceeding, we have added Docket No. ER04-901-000 to the caption here.

Following is the detailed agenda for the conference. To encourage dialog and discussion, we have not established specific times for presentations to commence, but have instead provided the sequencing of events for each day. Parties will have the opportunity to file supplemental comments following the conclusion of the conference.

The conference will be transcribed. Transcripts will be available to view in the above-listed dockets seven days after the conference.
