Dear Mr. Grabow:

1. On March 6, 2020, Meadow Lake Wind Farm VI LLC (Meadow Lake) filed an Offer of Settlement (Settlement) addressing Meadow Lake's annual revenue requirement for reactive supply and voltage control service from a wind turbine generating facility located in Benton and White Counties, Indiana and interconnected to the Indiana Michigan Power Company transmission system, which is under the operational control of PJM Interconnection, L.L.C. On March 26, 2020, Commission Trial Staff filed comments supporting the Settlement. On April 7, 2020, the Settlement Judge certified the Settlement to the Commission as an uncontested settlement.<sup>1</sup>

2. Article 4.1 of the Settlement states that

[t]he standard of review the Commission shall apply when acting on proposed modifications to this Settlement under section 205 or 206 of the Federal Power Act, including by the Commission acting *sua sponte*, shall be the ordinary "just and reasonable" standard of review.

3. The Settlement resolves all issues in dispute in Docket No. ER20-80.<sup>2</sup> The Settlement appears to be fair and reasonable and in the public interest, and is hereby approved. The Commission's approval of the Settlement does not constitute approval of, or precedent regarding, any principle or issue in these proceedings.

4. Meadow Lake submitted a live tariff record with the Settlement. The proposed effective date of that tariff record is 12/31/9998. We reject Meadow Lake's tariff record and direct Meadow Lake to make a compliance filing with revised live tariff records, in eTariff format,<sup>3</sup> with the effective date of December 9, 2019,<sup>4</sup> within 30 days of this order, to reflect the Commission's action in this order.
