FERC Proposes Incentives for Voluntary Cybersecurity Investments





FERC's Notice of Proposed Rulemaking (NOPR) would establish rules providing incentive-based rate treatment for utilities making certain voluntary cybersecurity investments. In the Infrastructure Investment and Jobs Act of 2021, Congress directed FERC to revise its regulations to establish incentive-based rate treatments by encouraging utilities to invest in advanced cybersecurity technology and participate in cybersecurity threat information sharing programs.

Commissioners Lead Transmission Planning & Cost Management Tech Conference

FERC conducted its first in-person tech conference at the Commission's headquarters in two and a half years on October 6, 2022, with a day-long look at transmission planning and cost management (AD22-8-000). The Commissioner-led conference featured five panel discussions with testimony and discussion among 38 stakeholder participants on topics ranging from local transmission planning criteria and cost management to regional transmission planning for reliability and cost management.
