



FERC Approves Incentive Rate Treatment for Cybersecurity Investments



FERC issued a [final rule](#) establishing incentive-based rate treatments to encourage utilities to invest in advanced cybersecurity technology and participate in cybersecurity threat information sharing programs for the benefit of consumers. This final rule is a result of Congress' directives under the Infrastructure Investment and Jobs Act of 2021.



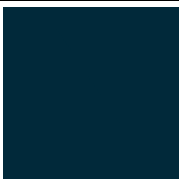
NERC Report on Grid Security

During the April Commission Meeting, NERC presented its [report](#) evaluating the physical security reliability standard and assessing physical attacks to the bulk power system. FERC directed NERC to produce the report in December 2022. FERC Chairman Willie Phillips stated the Commission will work with NERC to convene a technical conference on the matter.



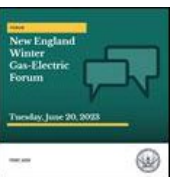
FERC Announces PJM Capacity Market Forum

The forum will feature three panel discussions to solicit varied perspectives on the current state of the PJM capacity market, potential improvements to the market, and related proposals to address resource adequacy.
