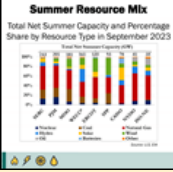




FERC Releases 2023 Summer Energy Market and Electric Reliability Assessment



The 2023 [Summer Assessment](#) provides Commission staff's outlook for energy markets and electric reliability focusing on the summer season from June to September 2023. Among this year's major findings: resource additions outpaced retirements, with rapid growth in storage capacity; natural gas prices are expected to be lower this summer, with high levels of natural gas production and storage; and the electric industry faces supply chain, economic and security concerns.



FERC Chairman Willie Phillips addresses Tribal Energy Equity Summit

On May 23, 2023, in St. Paul, Minnesota, Ojibwe & Dakota Territory, Chairman Phillips highlighted his commitment to engage and consult with Tribes on FERC proceedings potentially affecting Tribal interests. The Summit brought together leaders from Tribal and Federal governments to catalyze more meaningful and effective dialogue about clean energy siting, interconnection, and other critical energy and equity considerations.



PJM Forum Agenda and Speakers Announced

FERC previously announced it will hold a [Commissioner-led forum](#) to examine the PJM Interconnection capacity market on June 15, 2023, from 12:00 p.m. to 5 p.m. Eastern Time. A supplemental notice was issued on May 23, 2023, providing the agenda and speaker list for the event.



FERC Confirms New Transmission Task Force Members

The [Commission confirmed](#) the National Association of Regulatory Utility Commissioners' (NARUC) nominations of New Jersey Board of Public Utilities President Joseph L. Fioraliso and New York Public Service Commissioner John B. Howard to join the FERC-NARUC Task Force on Electric Transmission. The [next meeting](#) of the Transmission Task Force will take place Sunday, July 16, 2023, in Austin, Texas.
