FERC Announces 10/28, 11/4 Tribal Consultations on Pro Forma Interconnection Procedures

At the FERC September meeting, Chairman Phillips announced there will be <u>consultations</u> with federally recognized tribes on October 28 and November 4. The virtual meetings will focus on whether to conduct a rulemaking to revise the proforma Large Generator Interconnection Procedures.
