FERC Staff Presents 2024 State of the Markets Report

The annual report focuses on key information on market conditions and emerging issues in natural gas and electricity markets as well as significant market trends and fundamentals for the year.

“This report is consistent with reports we have been regularly receiving from NERC as well as RTO sources, such as from PJM and MISO. The combination of rapidly increasing electricity demand, driven by hyperscale customers such as data centers, paired with the alarming rate of base load generation retirements and lack of new dispatchable generation, is not sustainable and must be addressed,” said Chairman Mark Christie.

The Commission [voted](#) to approve the expansion of the Southwest Power Pool, Inc.'s (SPP) existing Regional Transmission Organization (RTO) into the West. It will span the Eastern and Western Interconnections, with three existing direct current connections between the interconnections totaling 510 MW of capacity to be made available for RTO operations.
